# Information on Disaster Compensation Policy

## Eligibility for mutual aid money and insurance benefits, and period of coverage

### Who is eligible

- PTA members (parents, teachers and administrative staff), and sponsoring members
- Preschool, elementary and junior high school students belonging to the subscribing PTA, and their relatives living with them

### Period of coverage

April 1st of the current year to March 31st of the following year

## Membership and fees

### Membership

- Members of each school PTA affiliated with the Mie PTA Association, and which are also subscribing members of this disaster compensation policy

### Fees

- 170 yen per household (this membership fee includes maintenance costs)
- Payment is made by the PTA of each school

## Mutual aid money will be paid in the following cases

### Mutual aid money for injuries

Mutual aid money will be paid in the event of a sudden and accidental external injury incurred while participating in a PTA event in Japan.



### Liability insurance benefit



Schedule of coverage	Mutual aid money
Mutual aid money for death	<b>3,700,000 yen</b> (300,000 yen in the case of sudden death)
Mutual aid money for residual disability (depending on the disability grade)	<b>3,700,000 yen – 150,000 yen</b>
Mutual aid money for hospitalization	<b>6,000 yen per day</b> (up to a maximum of 180 days)
Mutual aid money for surgery (once per accident) (Depending on whether or not the person is hospitalized for surgery)	<b>60,000 yen if hospitalized, 30,000 yen if not hospitalized</b>
Mutual aid money for out-patient treatment	<b>2,000 yen – 500 yen per day</b> (up to a maximum of 90 days)

※ Heat stroke and bacterial food poisoning are also covered.

※ The beneficiary of the mutual aid money will be the member or the member's legal heir.

The PTA will pay compensation and related expenses if the PTA is held legally liable for damage to the body or property of another person due to an accident resulting from the performance of PTA activities in Japan.

Liability associated with the performance of PTA activities	In the case of accidents resulting in bodily injury	Up to 100,000,000 yen per person Up to 500,000,000 yen per accident (no co-payment required)
	In the case of accidents resulting in property damage	<b>Up to 100,000,000 yen per accident</b> (no co-payment required)
Liability for stored goods	In the case of loss or damage to borrowed (stored) items	Up to 100,000 yen per accident Up to 10,000,000 yen during the period of insurance (co-payment of 5,000 yen per accident required)

This flyer only provides a summary of the policy. Please contact your school or preschool first in the event of an accident.

The accident may not be covered by this compensation policy.
